**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Lekhi Village, Near Iconic Dealer, PO/PS Nirjuli, Papum Pare District, Arunachal Pradesh for non-furnishing of information by The PIO-cum-Dy State Project Director, Govt. of A.P., SAMAGRA SHIKSHA / ISSE ,RMSA, Itanagar, P/Pare District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 07/03/2022 regarding the details of appointment orders of PTI & PTI Grade-II, PTT, PET, PRT, TGT.

2). **The 14<sup>th</sup> hearing was held on 5<sup>th</sup> November, 2024.** Shri Pokter Rime, the PIO –cum-DDSE, Govt. of A.P., Upper Subansiri District, Arunachal Pradesh and the Appellant Shri Nabam Tapak were present.

3). The PIO submitted that all the available information had been furnished to the Appellant and information not available furnished through AFFIDAVIT. The Appellant on the other hand submitted that information submitted were incomplete.

4). After hearing both the parties, the Commission directed the Appellant to give specific list of incomplete information as perceived by him. The list should be submitted to the PIO within ten days from the date of issue of this order under intimation to the Commission, failing which the Commission shall close and disposed of the case without any further notice.

5). The Commission directed the PIO to furnish information as per the list submitted by the Appellant. In case information are not available, the PIO was directed to furnish information through AFFIDAVIT with justifiable reasons, failing which the Commission shall invoke penal provision under section 20(1) of the RTI Act, 2005 against the PIO.

6) The Appellant was further directed to convey his satisfaction or dissatisfaction to the Commission in writing. On the basis of which next date of hearing shall be fixed or the case disposed of. It was cautioned to the Appellant that failing to convey in writing may also cause for disposed of the case without any further notice.


