**Information sought :**

The appellant file a RTI Application dated 07/05/2024 seeking Details regarding all Trading license of entire East Siang District and all Govt. notification act or order.

As per the case record, PIO has never conducted the hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 14/06/2024. First Appellate authority has conducted hearing on 18/07/2024. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

Appellant : Shri Liyit Panor found absent in the hearing.  
Respondent : PIO-cum-EAC, DC Office, Pasighat present.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Liyit Panor on **07.05.2024** filed an RTI application under Form-'A' before the PIO-cum-Extra Assistant Commissioner, O/o Deputy Commissioner, Pasighat, East Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **14.06.2024**, Appellant,

again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **19.08.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 236/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 05/03/2025. In this hearing of the appeal on 5<sup>th</sup> day of March, 2025, the PIO-cum-EAC, Pasighat present in person before the Commission but the appellant Shri Liyit Panor found absent without any intimation to the Commission. The appellant is directed to file before the F.A.A for the information under Section 6 of RTI Act which he is seeking.

Heard from the PIO-cum-EAC and perusing the case record and going through the Form 'A' application file by the appellant, the information available with the PIO has already been provided to the appellant. Receipt copy of the appellant is submitted today by the PIO. List of the document provided as per the Form 'A' has also submitted by the PIO which is in the case record. No specific information has been mentioned in the Form 'E' application by the appellant which was in the Form 'A' application. Appellant is seeking for refund of challan fee which he has already submitted before the PIO for documents he has already received.

It is to mention that the Commission has no authority to order for refund of any fee what so ever under the RTI Act.

It is also seen that the FAA has summoned both the parties and heard. The order passed by the FAA is upheld by the Commission today and the appeal case No. 236/2024 is disposed off and closed under Section 19(8) (d) of the RTI Act, Ex-parte.
