Second Appeal filed on : 22.08.2022

The appellant filed an RTI application dated 23.02.2022 Seeking detail information regarding D.P.R of Infrastructure under Khenewa year of sanction 2012-2013.

Details of information required:

1. Tender documents of C/o WRSB over Kameng River between Tapin to Dao village.
2. Tender documents of C/o WRSB Lnechi River between Lamnio to Warram Village.

3. Tender documents of C/o WRSB over walla river between Saria to Lancho village.
4. Tender documents of C/o WRSB over Waging River between Saria to Bengfong.
5. Name of detail address of Proprietor.
6. Name of Contactor, Firm and Power Attorney.
7. Contractor Registration no. class of Contractor.

Relevant facts emerged during hearing.

In ninth hearing ordered as: *"The commission observes that in all the 8 times hearing the PIO cum EE RWD Seppa Division did not attend the commission court though hearing notice issued to him. Even Show Cause Notice was issued to the EE, RWD Seppa. But no record is found as proof of RTI application received at PIO cum EE RWD Seppa office. Whereas the FAA directed EE RWD Seppa Division to furnish information, accordingly the EE RWD Bameng Division has furnished some information to the appellant on 8.12.2023 under intimation to this commission. In view of above facts and circumstances the proceedings on this appeal as per earlier hearings and orders is pertaining to EE Seppa RWD Division as PIO. The appellant shall submit a status report of the information furnished to him by EE RWD Bameng Division on 8.12.2023 to this commission within a period of two weeks from the date of issue of this order."*

The following were present.

Appellant : Present.

He states that the full information is not yet received from the PIO.

On interjection that there is no clarity in the concerned / correct PIO as RTI application is addressed as EE RWD Seppa Division (Bameng) Block Khenewa, East Kameng District, Seppa, the appellant states that RTI application was filed to EE, RWD Bameng Division.

Respondent PIO : Absent.

Decision:

The commission after adverting to the facts and circumstances of the case and hearing the parties observes that RTI application filed was addressed as PIO - EE, RWD Seppa Division (Bameng), Block Khenewa. Whereas this appeal case was proceeded for hearings with EE RWD Seppa Division as PIO, it is stated by the appellant that the RTI application was actually filed to EE RWD Bameng Division as PIO. It is seen from the document furnished by the EE Bameng Division that the pertaining Scheme in the RTI application: C/o Development of infrastructure under Khenewa CO Headquarter, AP is under Seppa Division. Whereas this appeal is against PIO – EE RWD Seppa Division but the RTI application was actually filed to EE Bameng RWD Division, no action can be initiated against EE Seppa RWD Division.

Since the concerned scheme pertains to EE RWD Seppa Division, the appellant is advised with direction to file a fresh RTI application to EE RWD Seppa Division as PIO. Now I find this appeal case fit to be closed and disposed off.

This appeal case is disposed of accordingly at Commission.
