JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Takar Jamoh on 12/12/2023 filed an RTI application under Form-'A' before the PIO-Cum- Deputy Director office of the Directorate of Land Management, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on 11/01/2024 the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 16/01.2024 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 131/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for six times i.e on dated 16/05/2024, 27/06/2024, 0/10/2024, 21/11/2024, 30/01/2025 & 03/04/2025. In this hearing of the appeal on 3rd day April 2025, the Appellant present during the hearing in person but PIO found absent during the hearing.

However, the Appellant has submitted a letter to the Commission by hand submitting that he has received all the information as sought in his Form 'A' application and has requested the Commission for disposal/closure of his appeal on ground of completely in receipt of all information sought from the PIO.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.
