**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Denny Lamgu for non-furnishing of information by the PIO, o/o the Divisional Forest Officer, Lohit, Lohit District as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 22.05.2024

**Facts emerging from the appeal:**

The records reveal that the appellant had requested the PIO o/o the Divisional Forest Officer, Likabali, Lower Siang Distt. for furnishing the following information:

1. Particulars of information: Regarding State CAMPA 2021-22 to 2023-24-
  - a) Annexure-A(2021-22);
  - b) Annexure-B (2022-23) and
  - c) Annexure-C (2023-24)
2. Details of information:
  - a) Details of work under CAMPA i.e approved AOP for 2021-22 to 2023-24;
  - b) Details of work order given to all the respective firm;
  - c) Details of department executed copy with bill voucher and challans;
  - d) NIT No and paper cutting of all works done with office work order of each item;
  - e) Department sanction order copy;
  - f) Details of respective firms and payment made by the department against the firm;
  - g) Copy of Range wise fund distributed by DFO;
  - h) Details of cheque leaf issued by DFOs and all Range Forest Officers to respective firms/contractor
  - i) Utilisation Certificate copy and photographs of every item of State CAMPA.

This appeal was heard for the 6<sup>th</sup> time on 30.04.2025 the last five hearing being on 22.11.2024, 10.01.25, 31.01.2025, 05.03.25 and 04.04.25.

In the hearing on 30.04.2025 the appellant was present physically but the PIO was absent. However, during the course of hearing, the PIO informed that

in compliance with the order dated 06.03.2025 passed by this Commission, his office had dispatched the requested information to the appellant with copy thereof to this Commission also.

This Commission, upon hearing the appellant in person and the PIO over phone, decided that on receipt of the documents so sent by the PIO through post, shall verify the same and take an appropriate decision/pass order.

This commission is now in receipt of the said documents on 2<sup>nd</sup> May, 2025 in a cartoon where-upon this Commission called the appellant in this Commission's office and opened the cartoon and found the documents having forwarded by a forwarding letter dated 25.04.2024.

On examination of the documents, this Commission found that the requested documents/information's are furnished head-wise but not properly indexed as per the detailed points requested by the appellant in his RTI application dated 22/05/24. As such neither this Commission nor the appellant himself could properly comprehend the information/reply vis-à-vis the details of points. This Commission, therefore, requires the assistance of the PIO/APIO or his representative to explain the point wise replies to the Appellant and the Commission.

As such this Commission directs the PIO/APIO or his representative to appear before this Commission on 13/05/25 to explain the point wise replies to enable to this Commission pass an appropriate order.
