**Information sought :**

The appellant file an RTI Application dated 11/10/2023 seeking Details regarding appointment of the details information of Er. As per the case record, PIO has never conducted the hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 11/10/2023. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tania June on **05.06.2023** filed an RTI application under Form-'A' before the PIO-Cum-Commissioner (PWD), Civil Secretariat, Itanagar, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **16.08.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **11.10.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 979/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 7 (seven) time i.e on **18/12/2023, 29/01/2024, 11/03/2024, 03/06/2024, 03/07/2024, 18/09/2024 and 30/10/2024**. In this hearing of the appeal on **30<sup>th</sup> day of October, 2024**, both the parties found absent, however, the appellant has sent a letter addressed to the Commission with a request to dispose of the appeal case No. APIC-979/2023 filed against the PIO-cum-Commissioner (PWD), Itanagar. The appellant also stated that all the information sought by him has been received from the PIO and satisfied.

On considering the request made by the appellant, the appeal case No. APIC-9792023 filed against the PIO-cum-Commissioner (PWD), Itanagar is disposed off and closed once for all.


