
JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Buli Bhai on **12.06.2023** filed an RTI application under Form- 'A' before the PIO-Cum-Block Development Officer, CD Block, Tamen Raga,, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **14.07.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **22.08.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 802/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 5 (five) time i.e on **21/12/2023, 02/02/2024, 06/05/2024, 19/06/2024 and 21/08/2024**. In this hearing of the appeal on 21st day of August, 2024, PIO present and the appellant found absent without any information to the Commission. The appellant was consecutively absent for 2 (two) occasion dated **19/06/2024, and 21/8/2024**.

As per the first hearing on 21/12/2023 both the parties were present and PIO has intimated to the Commission on that hearing that a letter was sent to appellant for collecting the information sought by him as per the Form 'A' application. The appellant also intimated to the Commission that he has received the letter on late. During the second hearing, the appellant found absent. The PIO has intimated to the Commission that he has brought all the information as sought by the appellant to be handed over to him, but due to the absence of the appellant, document sought by the appellant could not be handed over to him.

It is seen from the case record that the First Appellate Authority-cum-Deputy Commissioner, Kamle District has summoned hearings for 2 (two) times i.e., 31/08/2023 and 28/09/2023. The appellant was absent in both the hearings. It is seen that the appellant was given sufficient time which he has to collect the information and even the information sought was brought before the Commission. Considering all the facts of the case, the Commission deemed that the appellant has no more interest in getting the information sought by him.
