## **Information sought:**

The appellant file an RTI Application dated 10/11/2023 seeking Details regarding furnish certified copies of the Work/Tender and Notice, Date, Circulation & release of Work/Tender under Campas Fund against the DFO, Bhalukpong of Khellong Division Forest under for the period from 2020-2021, 2021-2022, 2022-2023.

The First Appellate has conducted hearing on 20th September, 2023 and decided ex-parte and disposed off the case.

Being dissatisfied on the order of First appellate authority and also not providing of documents by the PIO-cum-DFO, Khellong Forest Division. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Atul Thasusow on 10.07.2023 filed an RTI application under Form-'A' before the PIO-Cum-DFO, Khellong Forest Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 28.08.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 24.11.2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 1105/2023 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 4 (four) time i.e on 29/05/2024, 03/07/2024,16/09/2024 and 28/10/2024. In this hearing of the appeal on 28<sup>th</sup> day of October, 2024, representative of the PIO present through online mode and the appellant found absent. As per order date 16/09/2024 on 3<sup>rd</sup> hearing the information sought by the appellant was furnished on 31/07/2024. The appellant was asked to intimate his satisfaction or dissatisfaction regarding the document provided d to him by the PIO. Today on 4<sup>th</sup> hearing PIO-cum-DFO, Khellong Forest Division is represented by RFO, Bhalukpong and he has requested the Commission to dispose of the case. The information sought by the appellant had already been furnished on 31/07/2024 and the appellant was given sufficient time to go through the information provided to him. In the case record, it is seen that the appellant was absent on 3<sup>rd</sup> hearing and today on 4<sup>th</sup> hearing.

So, the Commission deems that the appellant is satisfied by the information provided to him and he does not want to pursue the appeal case.

Accordingly, the appeal case No. APIC1105/2023 filed against the PIO-cum-DFO, Khellong Forest Division is disposed off and closed once for all. However, the appellant has liberty to file appeal before the higher court, if he feels aggrieved by decision of the Commission.
