An Appeal Case U/S 19(3) of RTI Act, 2005. Vide Case No. APIC-184/2024

(Or. 5, R.3 of CPC)

ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Sorang Tayak on 17/08/2023 filed an RTI application under Form-'A' before the PIO-Cum- EE, Department of (RWD.) Tali Division, under Kra -Daadi District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 18.09.2023 the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 08.12.2023 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 184/2024 and processed the same for its hearing and disposal.
