An Appeal Case U/S 19(3) of RTI Act, 2005.
Vide Case No. APIC-184/2024

(Or. 5, R.3 of CPC)

Shri Sorang Tayak -V/S- PIO-cum- EE (RWD Tali Division, Govt. Govt. of Arunachal Pradesh.

ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Sorang Tayak on 17/08/2023 filed an RTI application under Form-'A' before the PIO-Cum- EE, Department of (RWD.) Tali Division, under Kra -Daadi District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 18.09.2023 the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 08.12.2023 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 184/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on **11th June 2024 & 06th August 2024**. In this hearing of the appeal on 6th day of August, 2024. The Appellant Shri Sorang Tayak and the PIO present during the hearing.

However, the Appellant Shri Sorang Tayak has submitted a letter to the Commission on **06/08/2024** that they have received all the information(s) as sought in his Form 'A' application and have requested the Commission for disposal/closure of their appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above facts and circumstances I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed off and closed once for all.
