ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, RTI Secy. (ALSU), Shri Lokam Tadam & Shri Tap Sajan for non-furnishing of information by the PIO, o/o the Executive Engineer (PHE & WS), Yupia Division, Papum Pare District, (A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide thier application dated 14.08.2023.

Records reveal that the appellants had sought for 12 (point) with around 9 sub-points each from the year 2016 to filing of RTI application i.e 14.08.23 regarding implementation of the schemes under fund allocated under JJM/NRDWSP/SBM(G) under Yupia Division. But having failed to obtain the sought for information from the PIO, the appellants approached the First Appellate Authority, the C.E (PHE & WS), Western Zone, Govt. of A.P, Itanagar under section 19(1) of the RTI Act vide their Memo of Appeal dt.15.09.23. Having failed yet again to obtain the information from the PIO, the Applicants/appellants filed their 2nd Appeal before this Commission under section 19 (3) of the RTI Act.

This appeal was, accordingly, heard on 8th of November, 2024 wherein the Appellant Shri Riya Taram was absent but the APIO, Shri Konya Lollen, A.E. o/o the E.E. (PHE and WS) Yupia Division, Papum Pare District, A.P. was present who informed the Commission that the documents are ready for handing over to the Appellant but the appellant has not turned up to collect the materials / information.

This Commission vide order dt. 12.11.2024 directed the appellant to collect the documents from the o/o the PIO and report his satisfaction or otherwise to this Commission on or before 4th December the next date of hearing and that in default, this appeal shall be disposed of and closed as not being pursued further by the appellant.

As directed the appellant had collected the information from the PIO and in today's hearing wherein the PIO was absent but the appellant who was present, informed that he had collected the sought for information from the PIO with he is satisfied and pleaded this Commission to dispose of and close the appeal.

In the premises as above, this Commission finds that no further interference is warranted on this appeal. Hence, this appeal stands disposed of and closed.
