

Information sought :

The appellant file an RTI Application dated 02/05/2023 seeking Details regarding Jaal Jeevan Mission Scheme of Tender and non-Tender copy from Package-22 August for Water Supply at Gaa.

As per the case record, PIO has never conducted the hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 12/10/2023. The First Appellate has been conducted hearing on 18/03/2025. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Nabam Sonu absent during the hearing
Respondent : PIO-cum-EE(PHE & WS) absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Nabam Sonu 02.05.2023 filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PHE & WS), Raga Division, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 12.10.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17.11.2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 1082/2023 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 06/08/2025. In this hearing of the appeal on 6th day of August, 2025, both the parties the appellant Shri Nabam Sonu and the PIO-cum-Executive Engineer (PHE & WS), Raga Division, Kamle District found absent. However, a request letter received from the appellant Shri Nabam Sonu for disposing of the appeal case No. APIC-1081/2023 /R/2025 & APIC-1082/2023/R/2025.

Request is accepted and the appeal case No. APIC-1081/2023/R/2025 is disposed and closed.

Judgment/Order pronounced in the open Court of this Commission today on this 6th day of August, 2025. Each copy of Judgment/Order be furnished to the parties.


