ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Takar Jamoh on **07.12.2024** filed an RTI application under Form-'A' before the PIO-Cum- Chief General Manager, (LPG) Indian Oil Corporation Ltd. Indian Oil AOD State Office, Sector III, PO- Noonmati, Guwahati, Assam whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **06.01.2024** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **16.02.2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 134/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for twice i.e on 16.05.2024 & 22.08.2024. In this hearing of the appeal on 22nd day of August, 2024. The Appellant Shri Takar Jamoh present during the hearing but the PIO found absent. .

However, the Appellant has submitted a letter to the Commission on 20.06.2024 that he has received all the information(s) as sought in his Form 'A' application and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above facts and circumstances I find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.
