JUDGMENT/ORDER

This is an appeal filed under sub-section 3 of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, |Shri Palen Laa on 31/7/2023 filed an RTI application in form 'A' before the PIO-cum EE (RWD), Raga Division, District Kamle, Govt. of Arunachal |Pradesh. Whereby seeking various information as quoted in Form 'A' applicant. The Appellant being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on 1/9/2023. Appellant again having not received the required information from the FAA, filed the second Appeal before the Arunachal Pradesh Information Commission on 3/10/2023 and the Registry of the Commission (APIC) having receipt of the complaint registered it as APIC No-950/202 (Appeal) and processed the same for its hearing and disposal. Accordingly, matter came up for hearing before the Commission for 1st hearing on 12/11/2023. In this hearing of the appeal on 12 th day of November' 2024, the representative of the PIO Shri Toba Riba A.E (RWD) and Appellant Shri Palen Laa present during the hearing.

The Appellant submitted a letter to the Commission stating that he has received all the information as sought in his Form 'A' application from the PIO and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information sought from the PIO.

In view of the above facts and circumstances I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed off and closed once for all.
