ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Palen Laa & Yukar Yaga, C/o Jollang Near Sonam Nursery, Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum- DPDO, Govt. of A.P. Raga, Kamle District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 14/08/2023 regarding expenditure & implementation of NON-BADP fund in Kamle District of Arunachal Pradesh.

The 1st hearing is held today on 28th May, 2024 as scheduled. The Appellant Shri Palen Laa is present. Shri Padi Tapa, the PIO-cum- DPDO, Govt. of A.P. Raga, Kamle District, Arunachal Pradesh appeared late in the court room. The PIO submitted that the matter is related to District Planning Officer (DPO) and not the District Panchayat Development Officer (DPDO) so the information should be sought from the DPO.

The Commission after going through the records available and submission made by the parties, it is found that matter has not been heard by First Appellate Authority (FAA) which is mandatory under the RTI Act, 2005.

Therefore, the appeal case is remanded to the FAA with the direction to summon all the parties, viz-DPO, DPDO and Appellant giving equal and fair opportunities of being heard in the interest of the natural justice and pass speaking order on merit. The Appellant is at his liberty to file fresh appeal to the Commission if he is aggrieved or not satisfied with the decision of the FAA. The case is disposed of and closed.
