**Information sought:**

The appellant filed RTI application dated 17.12.2022 seeking following information regarding detail information of various Schemes head of State and Central Funding, BADP, RIDF, NLCPR, SIDF, SADA, RE, UNTIDE, etc. for the financial year LOC 2017, amount Rs. 25.00 Lakh. In 2018, Rs. 815.94 Lakh in 2019 Rs. 216.20 Lakh. In 2020 Rs. 552.15 Lakh.

**Detail of information required:**

- (a) Furnish the copies of work award to the various contractors or M/S Enterprise as per Arunachal Pradesh district based entrepreneurship incentive & Promotional Development activities 2015.
- (b) Furnish the details of work order award various M/S Enterprise or Contractors viz: Trading License, Contractor Enlistment registration, ST, PRC, EPF, Aadhaar card, and in case of Individual contractors furnish the name of contractors along with Xerox copy of ID Proof documents Etc.
- (c) Furnish the Copies of cheque counterfoil, voucher bill/Challan of all transaction of the project/ schemes.
- (d) Furnish the Photograph copies of physical achievement along with visibly Colour scanning photo copies.
- (e) Name of Engineers, who have been prepared MB, Estimation, Site verification report.
- (f) Furnish the Transaction for bank statement according to norms EAT/ PFMS) system. (g) Site Inspection on Physical work Achievement is necessary.  
Period for which Information: 2017 to 2020.

**Previous hearings:**

- First hearing : 14.04.2023, PIO present & appellant present.
- Second hearing : 09.06.2023, PIO present & appellant present.
- Third hearing : 01.09.2023, PIO absent & appellant present.
- Forth hearing : 03.11.2023, PIO is represented by Shri Tapu Likha (ACE)& appellant present.
- Fifth hearing : 22.12.2023, PIO is represented by Shri Tapu Likha (ACE) & appellant present.
- Sixth hearing : 29.07.2024, PIO present & appellant present.

In sixth hearing, *"The commission has observed that the PIO has furnished the available information to the appellant, the commission has directed the PIO to fix a joint inspection of the work site on mutually convenient date. It is also necessary to examine the observation and order of the Hon'ble High Court of Delhi in conjunction with provision in the RTI Act 2005". A copy of the written submission by the PIO be furnished to the appellant. He shall file a written reply".*

**Relevant facts emerging during hearing:**

The following were present -

- Appellant : Present.  
The appellant pleaded for Inspection of work as per RTI application in form-A under clause (i) (j)

of the Section (2) of the RTI Act, 2005. He also states that interim order dated 22.12.2023 was issued by the commission for joint inspection of the work.

Respondent PIO : Shri Tame Ekha AE, APIO sates that he has joined at WRD Division, Itanagar recently and do not have thorough knowledge about this appeal case.

**Decision:**

The commission after adverting to the facts and circumstance of the case, hearing the parties and perusal of the records, observes that the written submission dated 29.07.2024 made by the PIO cites the order in the W.P (C) 4675/2012 PIO, Govt. of NCT of Delhi Versus Saurabh Sharma & Ors in the High Court of Delhi for denial of inspection of work.

Whereas this High Court of Delhi order is concerning to PIO of Govt. of NCT of Delhi. There is no proof of circulation of this order officially through appropriate nodal department of the central government and state govt. of Arunachal Pradesh. Whereas the Works projects information sought are visibly of open public utility infrastructure work site. They are not hidden or isolated work site.

Therefore, the inspection of the work under this appeal case is allowed. The inspection of the work shall be completed within one month from the date of issue of this order i.e before 12<sup>th</sup> January 2025. The PIO shall show the work site to the appellant. The appellant and PIO shall submit compliance report of this order to this commission within 40 days from the date of issue of this order.
