**Information sought :**

The appellant file an RTI Application dated 27/03/2024 seeking Details regarding Schemes taken by Capital Electrical Division (ICR)

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 23/04/2024. The First Appellate Authority has conducted the hearing on 20/06/2024. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Techii Reeb on **27.03.2024** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (Power), Capital Region, Itanagar, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **23.04.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **17.10.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 301/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 12/03/2025 and 16/04/2025. In this hearing of the appeal on 16<sup>th</sup> day of April, 2025, the PIO-cum-Executive Engineer (Power), Capital Division present in person but the appellant Shri Techii Reeb found absent without any intimation to the Commission.

As per the case record, on the last hearing dated 12/03/2025, the appellant was found absent and the appellant was directed to be present in person before the Commission in next date of hearing i. e., today dated 16/04/2025. The appellant was also directed to mention clear and specific scheme which he is seeking to the PIO in writing. But appellant failed to comply the direction of the Commission.

In the last hearing the appellant was given last chance to appear but he is found absent without any intimation to the Commission.

The Commission deems that the appellant is no more interested to pursue the appeal case. Therefore, the appeal case No. APIC-301/2024 is disposed off and closed in his absence.


