**Information sought :**

The appellant file an RTI Application dated 28/05/2024 seeking Details regarding Cash Book statement from 2023 to till date and Treasury Challan voucher along with amount withdrawn in the name of EE.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 06/07/2024. The First Appellate Authority has conducted the hearing on 11/09/2024. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

Appellant : Shri Lazala Singpho attended the hearing through VC

Respondent : PIO-cum-EE (Electrical), Miao Division attended the hearing through VC.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Lazala Singpho **28.05.2024** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (Electrical), Miao Division, Changlang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **06.07.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **05.11.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 311/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3(three) times i.e on 12/03/2025, 16/04/2025 and 30/04/2025. In this hearing of the appeal on **30<sup>th</sup> day of April, 2025**, both the parties the PIO-cum- EE (Electrical) , Miao Division, Changlang District and the appellant Shri Lazala Singpho attended the hearing through VC.

During the hearing, the PIO has stated that he has given all the documents as sought by the appellant to him. The appellant also accepted that information has been furnished by the PIO in abstract copy but is not satisfied by the information provided in abstract copy. Considering submission from both the parties, the Commission is convinced that the information sought by appellant is provided.

Therefore, the Commission deems fit to dispose the appeal case. Accordingly, the appeal case No. APIC-311/2024 is disposed off and closed.

If the appellant feels aggrieved by the decision of the Commission, he is at liberty to file appeal before the appropriate authority.
