**ORDER**

- 1). The case was an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Takar Jamoh, Bank Tinali, Near Head Post Office, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-DLRSO, Govt. of A.P., O/o the Deputy Commissioner, Namsai, Namsai District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 04/04/2024 regarding Land Occupation Certificate of Shri Oni Deori.
- 2). The 1<sup>st</sup> hearing was held on 19<sup>th</sup> November, 2024. The PIO-cum-DLRSO, Govt. of A.P., O/o the Deputy Commissioner, Namsai, Namsai District, Arunachal Pradesh was found absent. The Appellant Shri Takar Jamoh was present in person before the Court.
- 3). The Commission had directed to give a fresh hearing date to the Appellant before the Court of First Appellate Authority, Namsai District, Arunachal Pradesh under intimation to the Commission. The Appellant was also directed to get back to the Commission within one week after the hearing before the Court of FAA, failing which the case would be disposed of without further notice.
- 4). The Appellant vide letter No. NIL dated 26/11/2024 informed the Commission that he has not received any intimation from the office of the FAA for the hearing. However, the Commission had received a copy of summon notice issued to the Appellant and the PIO by the FAA vide Memo No. ND-13(Pt-II)/RTI/2024/8496-99 dated Namsai, the 12<sup>th</sup> December, 2024. The date and time for hearing was fixed on 24/12/2024 at 10:00 AM.
- 5). It was observed that both the FAA and the PIO had not intimated the outcome of the hearing to the Commission. The Commission directed the FAA and the PIO to submit the reports of the hearing and action taken.



6). The PIO, through WhatsApp, shared a hearing Order copy of the FAA. As per the hearing Order copy dated 21/12/2024, the Appellant had submitted that the additional information was furnished by the PIO-cum-DLRSO on 11<sup>th</sup> December, 2024 and accordingly the Appellant had withdrawn his appeal.

7). The Commission in view of the above order copy of the FAA and non intimation by the Appellant, hereby decides to dispose of the case.

**Therefore, the case is hereby disposed of.**
