**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Takheng Lamnio on **21.02.2023** filed an RTI application under Form-'A' before the PIO-Cum-Extra Assistant Commissioner, Seppa, East Kameng, District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **27.03.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **16.05.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 422/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for **8 (eight) times** i.e on **26.06.2023, 07.08.2023, 25.09.2023, 16.10.2023, 04/12/2023, 22.01.2024, 08.04.2024** and **12.06.2024**. In this hearing of the appeal on **12<sup>th</sup>** day of June, 2024, Appellant Shri Takheng Lamnio present but PIO-cum-Extra Assistant Commissioner, Seppa found absent.

As per order dated 04/9/2023 during the 5<sup>th</sup> hearing, the Commission invoked under Sub-Section (1) of Section-20 of the RTI Act, 2005 and imposed penalty amount of Rs. 25,000/- (Rupees twenty five thousand) only against the PIO for violation of Sub-Section (1) of Section-7 of the RTI Act, 2005. And the PIO was also directed to furnish the copy of the penalty deposit treasury challan to the Commission. Moreover, the PIO was again directed to compensate the appellant a sum of Rs. 5000- (Rupees five thousand)only for monetary losses which incurred during to & fro journey expenses etc.

The PIO has deposited the penalty amount and treasury challan is submitted in the Commission. PIO has submitted an affidavit declaration stating that information available is already furnished to appellant and remaining information sought by the appellant is not available in the office record.
