The appellant submits that neither the PIO - EE, IMC Itanagar has provided him the information nor the FAA - Commissioner, IMC, Itanagar has heard his first

appeal filed to him within time frame prescribed in RTI Act, 2005. So, he has filed second appeal to this commission court.

Respondent APIO Er. Kipa Karu states that RTI application in Form - A received from the appellant Shri Tania June has been misplaced in the PIO's office and requested for fresh application.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records, observes that FAA has not disposed of the first appeal filed to him. The instant appeal case is remanded to First Appellate Authority. Therefore, the FAA - Commissioner, Itanagar Municipal Corporation, following the principle of natural justice, shall conduct hearing giving fair and equal opportunity to both the appellant and the PIO and thereafter pass reasoned and speaking order on merit within three weeks from the date of receipt of this order.

The appeal is disposed of accordingly at Commission.
