JUDGEMENT / ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Khunkam Pansa on 18.07.2023 filed an RTI application in Form-A to the PIO cum DHO, Longding District A.P, whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority cum Director (Horticulture) Itanagar on 25.08.2023.

Appellant again having not received the required adequate information or decision from FAA, filed the Second Appeal before the Arunachal Pradesh information commission on 29.09.2023.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.938/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for hearing before the Commission Court today on 23.08.2024. Notice of hearing dated 03.07.2024 were served to FAA, PIO and the Appellant.

In this hearing of the appeal on 23.08.2024 the respondents PIO is represented by Shri Jaman Rangkhram HDO, APIO and the FAA Mrs Y. Jini Ado Director (Horticulture) GoAP Itanagar PapumPare District is present. The appellant Shri Khunkam Pansa did not appear.

Heard the FAA & PIO's representative.

Both the FAA & PIO's representative submitted that all the sought information has been provided to the appellant.

The appellant has requested the Commission to close and dispose of this appeal case with written submission letter dated 23rd August 2024 as he has received complete and correct documents from the PIO against his RTI application.

In view of the above facts and circumstances I find this appeal is fit to be disposed of and closed. Accordingly, this appeal stands disposed of and closed once for all.
