ORDER

- 1). The case was an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Takar Jamoh, Bank Tinali, Near Head Post Office, Itanagar, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, Govt. of A.P., O/o the Deputy Commissioner, Namsai District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 08/06/2024 regarding Land Occupation Certificate of Shri Oni Deori.
- 2). The 1st hearing was held on 19th November, 2024. Shri Khaleen Saroh, the PIO-cum-CO, Govt. of A.P., O/o the Deputy Commissioner, Namsai District, Arunachal Pradesh had appeared before the Commission's Court through Video Conferencing (Hybrid mode of hearing). The Appellant Shri Takar Jamoh was present in person before the court.
- 3). The Commission had directed to give a fresh hearing date to the Appellant before the Court of First Appellate Authority, Namsai District, Arunachal Pradesh under intimation to the Commission. The Appellant was also directed to get back to the Commission within one week after the hearing before the Court of FAA, failing which the case shall be disposed of without further notice.
- 4). The Appellant vide letter No. NIL dated 26/11/2024 informed the Commission that he has not received any intimation from the office of the FAA for the hearing. However, the Commission received a copy of summon notice issued to the Appellant and the PIO by the FAA vide order No. ND-13(Pt-II)/RTI/2024/8491-95 dated Namsai, the 12th December, 2024. The date of hearing was fixed for 24/12/2024.

5). Vide Order No. FAA-No. 08(1) / 2024 (Appeal) / 8861 Dated 24/12/2024, the FAA-cum-DC Namsai, in presences of both the parties have heard the case and disposed of the same.

6). The Appellant has failed to intimate the Commission despite sufficient time provided and cautioned.

7). Therefore, the case is hereby disposed of.
