JUDGEMENT / ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Tania June on 23.01.2023 filed an RTI application in Form-A to the PIO-Cum-EE, UD & Housing Ziro Division, Lower Subansir District A.P., whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority Cum EE, UD & Housing Ziro Division, Lower Subansir District Govt. of A.P on 29.03.2023.

Appellant again having not received the required adequate information or decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 15.05.2023.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.472/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for hearing before the Commission Court today on 09.09.2024. Notice of hearing dated 12.08.2024 were served to PIO and the Appellant.

In this hearing of the appeal on 09.09.2024 the PIO cum EE UD & Housing Division Ziro Lower Subansiri District AP and the FAA Cum CE UD & Housing, Itanagar both absent. The appellant Shri Tania June appeared.

Heard the appellant.

The appellant has requested the Commission to close and dispose of this appeal case with written submission letter dated 21<sup>st</sup> August 2024 as he has received complete and correct documents from PIO Cum EE, UD & Housing, Ziro Division, Lower Subansiri District against his RTI application and he is fully satisfied with it.

In view of the above facts and circumstances I find this appeal is fit to be disposed of and closed. Accordingly, this appeal stands disposed of and closed once for all.
