JUDGEMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Charu Tatung on 30.01.2024 filed an RTI application under Form-'A' before the PIO-Cum-DLRSO, O/o the Deputy Commissioner, Capital Complex, P/Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 04.03.2024 Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 09.04.2024 and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as APIC No. 170/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for once i.e on 04.06.2024. In this hearing of the appeal on 4th day of June, 2024. The Appellant present during the hearing but the PIO found absent.

However, the Appellant has submitted a letter to the Commission during the hearing stating, that he has received all the information as sought in his Form 'A' application and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information sought from the PIO.

In view of the above facts and circumstances I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed off and closed once for all.
