## **ORDER**

This is an appeal under Section 19 (3) of RTI Act, 2005 received from Shri Nabam Johan for non-furnishing of information by the PIO, o/o the E.E (PWD), Naharlagun Division, Govt. (A.P) as sought for by him under Section 6(1) (Form-A) of RTI Act,2005 vide his application dt.19.07.2023.

The hearing of this appeal was scheduled for 3 (three) times on 14.07.2024, 24.07.2024 and 30.08.2024. The parties did not turn up on 14.07.2024 and 24.07.2024 but on 30.08,2024, the appellant attended the hearing.

After hearing this appeal on 30.08.2024 and on finding that this appeal had not been considered by the First Appellate Authority (FAA), the Superintendent Engineer, (APPWD), Govt. of A.P, Capital Circle, Itanagar under section 19(1) of the RTI Act, 2005, this Commission, vide order dt.04.09.2024, remanded to the FAA for adjudication and passing an appropriate speaking order within four weeks from the date of receipt of the order with liberty to the Appellant Shri Nabam John to prefer 2<sup>nd</sup> appeal before this Commission under Section 19(3) of the RTI Act, if he is aggrieved with the order/decision of the F.A.A.

Now, this Commission is in receipt of letter No. ND/RTI-308/NJ/2024-25/97 dt. 16.10.2024 from the PIO, the Executive Engineer (PWD), Naharlagun Division addressed to the S.E, Capital Circle, PWD AP, Itanagar inclosing therewith a copy of letter dt.07.10.2024 from the Applicant /Appellant, Shri Nabam Johan, addressed to the Ex. Er., the PIO, intimating that he had physically verified the office documents relating to his queries on maintenance and repair works under Naharlagun PWD division and that he found the documents in order & satisfied and further stating that he has withdrawn his RTI application dt.19.07.2023.

The said letter of the PIO, a copy whereof is endorsed to this Commission, states that the FAA, in compliance of the order dt.04.09.2024 passed by this Commission, had conducted a hearing on 24.09.2024 and passed an order No. SECC/E-VIII/48/2024-25/46 dt.24.09.2024.

The copy of the said order is, however, not annexed in the said letter. Nevertheless, this Commission, going by the letter dt.07.08.2024 of the Applicant/Appellant whereby he had withdrawn his application for information, finds this appeal fit to be closed which it hereby does.
