JUDGEMENT/ORDER

This is an appeal file under sub-section (3) of section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Sama Yangfo on 24/04/2023 filed an RTI application under Form 'A' before the PIO-Cum-Executive Engineer, (RWD), Bameng Division, Govt of Arunachal Pradesh whereby seeking various information, as quoted in Form-A application. The appellant having not received any documents from the FFA filed an appeal before the Commission.

Accordingly, matter come up for hearing before the Commission i.e on 18/09/2023, 11/12/2023, 29/01/2024, 08/05/2024 and 24/06/2024

The PIO was consecutively absent during the hearings on 18/09/2023, 06/11/2023, and 11/12/2023. The Commission issued a show Cause notice to the PIO to appear the before the Commission on 29th January 2024 and reply to the notice.

That in spite of the show cause notice, the PIO did not turn up before the Commission on 29th January 2024. The Commission ordered for penalty of Rs25000/ against the PIO under section 20(1) of the RTI Act and compensation of Rs5000/ for the appellant.

That on 5th hearing dated 08/05/2024, last warning was given to the PIO to deposit the penalty amount and compensation for the appellant.

That on 6th hearing dated 24/06/2024, the PIO while complying with the order of the Commission, submitted the deposit treasury challan for penalty and compensation of Rs 25000 was given to the appellant.

That the PIO also submitted an affidavit declaring that the information sought in Form A by the appellant is not available in his office.

In view of the above fact and circumstances, the commission deemed fit to be dispose off and closed the case . An accordingly, this appeal case APIC No. 588/2023, stands disposed off and closed once for all.
