**Information sought :**

The appellant file a RTI Application dated 13/03/2024 seeking Details regarding Street Light under BE 2019-2020.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 23/04/2024. First Appellate Authority has conducted hearing on 20/09/2024. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Techii Reeb on **13.03.2024** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (Power), Capital Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **23.04.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **17.10.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 301/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 12/03/2025. In this hearing of the appeal on 12<sup>th</sup> day of March, 2025, both the parties, PIO-cum-Executive Engineer (Power) Capital Division is represented by Er. Ripon Kabak, but the PIO Shri Techii Reeb found absent without any intimation to the Commission.

PIO has stated before the Commission today that no such scheme as sought by the appellant is available in the department. After going through the case record, it is seen that the hearing was conducted by the First Appellate Authority and the PIO-cum-EE (Power) Capital Division has filed the reply addressing to the appellant stating that there is no any scheme of name as information sought by the appellant. The reply copy addressed to the appellant Shri Techii Reeb is enclosed in the case record. After going through the case record, considering the submission made by the PIO, the Commission deems fit to dispose off and closed the appeal case relying upon the PIO's statement.

The Commission deems that there is no such information available with the PIO which sought by the appellant.

Accordingly, the appeal case No. APIC-300/2024 is disposed off and closed.
