This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Engo Melo, Alinye, Anini, Dibang Valley District, Arunachal Pradesh for non-furnishing of information by the Public Information Officer (PIO), Govt. of A.P., O/o Deputy Commissioner Anini, Dibang Valley District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 16/03/2023 regarding Advance Landing Ground, Alinye.

**The 7<sup>th</sup> hearing is held on 30<sup>th</sup> July' 2024'(Tuesday) at 1030 hrs.** Ms. Pimiya Micro, CO Anini the Public Information Officer (PIO), Govt. of A.P., O/o Deputy Commissioner Anini, Dibang Valley District, Arunachal Pradesh is present through hybrid mode. The Appellant Shri Engo Melo is found absent. The PIO has submitted that the available information which was kept ready was collected by the Appellant from her office. The Appellant was asking for Preliminary land acquisition and notification but no land acquisition and notification was done. But it was the willingness of the public to donate the land to the Airport authority which was already informed to the appellant in the last hearing.

The Appellant is found absent today and no representative has been present on behalf of him in the court. So, it is presumed that the Appellant is satisfied with the information so furnished by the PIO. During the 6<sup>th</sup> hearing, it was clearly mentioned in the order that if the Appellant is found absent, the case shall be disposed of without any further notice.

**Therefore, the case is disposed of and closed.**
