Information sought: The appellant filed an RTI application dated 02.07.2024 seeking following information Relating to the Commercial and residential plot allotted to Shri Navin Ratan, S/o Lt. Toni Ratan.

Detailed of information required: (i) Allotment order issued in favour of Shri Navin Ratan S/o of Lt. T. Ratan, against the commercial building registered under the name "Hotel Alpine" at central Ganga market, ICR near LIC Office, Ganga, Itanagar.

(ii)Detail information of residential plot allotted to Shri Navin Ratan S/o of Lt. T. Ratan and the allotment under copy of the name located at C Sector, Itanagar, near Chief Secretary Bungalow/ opposite to YASSO APARTMENT.

Appellant : Present. He has received the information during the hearing and requested for closure of appeal case.

Respondent PIO : Present. He states that the Form A had been transferred from Land Management Department to the FAA – DC Office, ICR.
