## JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Takam Sakap on 24.05.2023 filed an RTI application under Form-'A' before the PIO-Cum-Executive Engineer (PWD), Palin Division, Kr-Daddi District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 27.06.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 28.07.2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 715/2023 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 5 (five) time i.e on 09/10/2023, 29/11/2023, 22/01/2024, 10/04/2024 and 12/06/2024. In this hearing of the appeal on 12<sup>th</sup> day of June, 2024, both the parties found absent however, the PIO detailed his representative namely Er. Nangbia Tedi, AE-cum-APIO (PWD), Palin.

Since, the appellant has been absent consecutively for last 3 (three) hearing on dated 22/01/2024, 10/04/2024 and 12/06/2024, inspite of giving Last Warning Summon Notice. The appellant were given sufficient time/chance to appear before the Court of Commission through whattsup and official correspondence but he failed to comply the directions of the Commission. It seems that the appellant is no more interest in pursuing the case in seeking information.

In view of the above facts and circumstances, I find this appeal fit to be disposed off in the absence of the appellant. And, accordingly, this appeal stands disposed off and closed once for all.
