<u>ORDER</u>

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Talin Dignium on 26.09.2023 filed an RTI application under Form-'A' before the PIO-Cum-EE, Department of PHE & WS Division, Daporijo, U/Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 08.12.2023 Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 12.03.2024 and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as APIC No. 148/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for twice i.e on 09.05.2024 & 20.06.2024. In this hearing of the appeal on 20th day of June, 2024. The Appellant Shri Talin Dignium present during the hearing but the PIO found absent.

Heard the Appellant.

The Appellant stated before the Commission that he has received complete information but it has not been compiled properly in regard to paging the documents year wise, which makes him difficult to understand and co-relate the information(s).

Upon the statement of the Appellant, the Commission/Court is convinced and satisfied with the PIO that, the PIO has provided the complete information to the Appellant as directed/ordered by the Commission. This Court has a view that paging can be done easily by any of the competent office staffs to compile the documents for the easy and best understanding of the Appellant.

The Commission ordered;

- i. The Appellant to approach the PIO to compile properly regarding the paging of the documents for better understanding as furnished to him by the PIO.
- ii. The PIO to assist the Appellant in compiling the information by proper paging of the documents for easy understanding of the Appellant.

In view of the above facts and circumstances, I find this appeal fit to be disposed off and closed, hence, this Court/Commission does not find any reason for further hearing to be conduct. And, accordingly, this appeal stands disposed off and closed once for all. Judgment/Order pronounced in the open Court of this Commission today on this 20th day of June, 2024.
