JUDGMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Mating Tunar on **15.09.2023** filed an RTI application under Form-'A' before the PIO-Cum- EE, PWD, Palin Division, Kra- Daadi District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **17.10.2023** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **29.01.2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 70/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for thrice i.e on 04.04.2024, 02.05.2024 & 06.06.2024. In this hearing of the appeal on 6th day of June, 2024. The Appellant and the APIO, Shri Nangbia Tedi present during the hearing.

Heard both the parties.

The APIO stated before the Commission that the PIO has furnished all the information(s) to the Appellant through post office on dated 05.06.2024 and a copy of the forwarding letter furnishing of the information(s) submitted before the Commission.

After hearing the APIO and going through the letter submitted by the APIO, the Commission directed the Appellant , that after receiving and going through the information(s), convey to the Commission whether the complete information have been received or not. And the Commission also ordered/directed the PIO, if the Appellant is not in receipt of the complete information(s) as applied, he may again furnish the information(s) to the Appellant as sought in his form 'A' application.

And hence, this appeal is disposed off and closed with the liberty given to the Appellant that if the information(s) is found insufficient as provided by the PIO to let the Commission know.

In view of the above facts and circumstances I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed off and closed once for all.
