**JUDGEMENT**

This is a complaint filed under sub-section (1) of Section 18 of the RTI Act, 2005. Brief fact of the case is that the Complainant Shri Marge Lombi on **17/08/2023** filed an RTI application under Form- 'A' before the PIO-Cum-EE (power) Likabali Division under Lower Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Complainant, being not satisfied with the information received from the PIO, filed the Second Appeal before the Arunachal Pradesh Information Commission on **08.12.2023** and the Registry of the Commission (APIC), having receipt of the Complaint registered it as **APIC No. 1/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on **13/06/2024** & **08/08/2024**. In this hearing of the Complaint on 8<sup>th</sup> day of August, 2024. The Complainant Shri Marge Lombi and PIO heard through whatsapp via video call.

Heard both the parties.

However, the Complainant Shri Marge Lombi, stated that as per the order passed in the last hearing on dated 13.06.2024 that the PIO has provided all the information as sought in his form 'A' application and has requested the Commission for disposal/closure of his Complaint on ground of satisfactorily in receipt of all information (s) as sought from the PIO.

In view of the above facts and circumstances I find this Complaint fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.
