ORDER

Facts:

The brief facts of the case, as reveal from the records, are that the appellant, Shri Nangbia Kasa, vide his application dt. 24.03.2023 filed before the Public Information Officer o/o Chief Engineer (W/Z), Department of Hydro Power, Govt. of A.P, Itanagar has sought the information regarding the fund sanctioned for special repair of Mai Ph-II (2x500 KW) (SH Power House & EM Equipment) and C/o R & M of unit-II of Mai PH-II (2x500 KW) at Mai (Yachuli).

The appellant having failed to obtain the information from the PIO, filed first appeal before the First Appellate Authority, the Chief Engineer (W/Z) Department of Hydro Power, Govt. of A.P, Itanagar vide his Memo of Appeal dt 31.05.2023. But dissatisfied with the non-response from the FFA, the Appellant preferred this Second appeal before the Commission.

Hearing and decision:

The appeal was heard for 2(two) times on 31.05.2024 and 21.06.2024.

In the first hearing on 31.05.2024, the appellant attended the hearing but the PIO was absent. However, in the second hearing on 21.06,2024, both the appellant and the APIO, Er. Shri Taba Tagu attended the hearing.

During the course of hearing, the APIO, handed over the sought for information to the appellant with a copy thereof to the Commission. The appellant went through the documents and expressed his satisfaction thereon and thus both the parties pleaded for closure of the case.

Under the premises as above, the appeal is hereby closed and disposed of accordingly.
