JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Riya Taram on **04/04/2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PWD), Basar, Leparada District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **16/05/2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **27/06/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 598/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 8 (eight) times i.e on 18/09/2023, 06/11/2023, 18/12/2023, 29/01/2024, 29/04/2024, 17/06/2023, 12/08/2024 and 09/09/2024. In this hearing of the appeal on 9th day of September, 2024, the PIO-cum-Executive Engineer (PWD), Basar present but, the appellant Shri Riya Taram found absent without any intimation to the Commission.

In the last 2 (two) orders on 17/06/2024 and 12/08/2024, it was already ordered by the Commission that if the appellant fails to be present, the appeal case will be decided ex-parte in his absence. In the case record, the appellant was **absent on 6th hearing on 17/06/2024, 7th hearing on 12/08/2024 & 8th hearing on 09/09/2024**. Sufficient time and chance has been given to the appellant to be present. But he failed to attend in the Commission Court. The commission deems that the appellant is no more interested in his appeal case.
