JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on 31.08.2023 filed an RTI application under Form-'A' before the PIO-Cum-Executive Engineer (RWD), Seppa Division, East Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 03.10.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 10.11.2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 1041/2023 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 27/01/2025. In this hearing of the appeal on 27th day of January, 2025, the appellant present in person but the PIO-cum-Executive Engineer (RWD), Seppa Division, East Kameng District found absent without any intimation to the Commission.

However, the appellant has stated before the Commission today on 1st hearing that the said appeal case has already been disposed off by the PIO-cum-EE (RWD), Seppa Division and requested to close the appeal case No. APIC-1041/2023.

Accordingly, this appeal case is disposed off and closed once for all on the request made by the appellant.
