The appellant file an RTI Application dated 31/08/2023 seeking Details regarding SIDF, SADA, ADA, RIDF Scheme under Seppa Division.


As per the case record, PIO has never conducted the hearing under his jurisdiction.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on **31.08.2023** filed an RTI application under Form-'A' before the PIO-Cum-Executive Engineer (RWD), Seppa Division, East Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **03.10.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **10.11.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 1041/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 27/01/2025. In this hearing of the appeal on 27<sup>th</sup> day of January, 2025, the appellant present in person but the PIO-cum-Executive Engineer (RWD), Seppa Division, East Kameng District found absent without any intimation to the Commission.

However, the appellant has stated before the Commission today on 1<sup>st</sup> hearing that the said appeal case has already been disposed off by the PIO-cum-EE (RWD), Seppa Division and requested to close the appeal case No. APIC-1041/2023.

Accordingly, this appeal case is disposed off and closed once for all on the request made by the appellant.
