**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Riya Taram , Adv. Lokam Tadam & Adv. Tap Sajan on **17/08/2023** filed an RTI application under Form-'A' before the PIO-Cum- EE, Department of Power, Romgong Division, Siang District , Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **18.09.2023** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **08.12.2023** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 103/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for twice i.e on 07.05.2024 & 11.06.2024. In this hearing of the appeal on 11<sup>th</sup> day of June, 2024. Both the parties found absent during the hearing without intimating the reason for their inability to attend the hearing.

The Commission after going through the order passed in the last hearing on dated 07.05.2024, it was observed that the Appellants were twice summoned to appear before the Commission and to collect the information from the PIO's good office by depositing requisite fees and intimate their receipt of the information to the Commission, but they failed to appear before the Court/Commission.

On the above facts & circumstances, the Commission opines that the Appellants have collected/received the information from the PIO and they are fully satisfied with the information received from the PIO or they are no more interested for further conduct of hearing to their appeal. Hence, the Commission finds this appeal fit to be disposed off and closed and is disposed off today.
