ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (PWD), Khonsa, Dist. : Tirap, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 03.12.2024.

(A) Particular of information: C/o "Margherita – Deomali Road (15.458 km) under the North East Road Sector Development Scheme (NERSD) during the financial year 2020-21.

B) Details of information required:

1. Certified sanction order copy of the total list of project mentioned above.
2. Certified copy of utilization certificate.
3. The certified copy of Notice Inviting Tender (NIT) with respect to the subject mentioned above.
4. The certified copy of Newspaper in which the NIT was published (at least 3 newspaper names (one national & 2 locals) along with the date of publication of newspaper as per Govt. approved order.
5. The Tender Evaluation copy (Technical Bid) along with the list of Firms participated in the tender processed for the work.
6. The name of firm who won the tender work with respect to the subject mentioned above.
7. The certified copy on which date the project has been started.
8. Certified copy of completion certificate for the subject mentioned above. The certified full agreement copy made in between the executing agency and the firm owner.
9. The Geo Coordinate information for work mentioned above.
10. The certified photograph of worksite (color photo) before starting of work and after completion of work.
11. Name of Officers and their Designation at the time of monitoring the work.
12. Certified full agreement copy made in between the executing agency and the firm owner
13. The certified copy of Contractor Registration, Trading License, GST No., GST Return 3B filled for previous Tax period.
14. The certified copy of contractor Enlistment Update Reports, of tender winning firm.

The records in the Appeal disclose that the appellant, vide his application dt.02.09.2024, had requested the PIO for the aforementioned information but could not obtain the same which prompted him to approach the Chief Engineer (PWD), Eastern Zone, Namsai vide his Memo of Appeal dt.09.10.2024 but yet again he could not obtain the sought for information from the PIO within the statutory period. Hence, the appellant, filed his 2nd appeal before this Commission under section 19(3) of the RTI Act, 2005 vide his Memo of Appeal dt.03.12.2024 which has been registered in this Commission as APIC-412/2024 and accordingly, listed for hearing on 26.03.2025.

In the meantime, however, the Appellant, vide his letter dt.25.03.2025, intimated this Commission that he has received all the information from the PIO concerned and that he is satisfied therewith and accordingly requested this Commission to dispose of the appeal.

In the premises as above, this appeal does not warrant any hearing and adjudication by this Commission and resultantly, it stands disposed of and closed.
