**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Palen Laa & Smti Yukar Yaga on **20/06/2023** filed an RTI application under Form-'A' before the PIO-cum-District Land Revenue & Settlement Officer (DLRSO), Raga, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **24/07/2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **24/08/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 816/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 5 (five) times i.e on 13/11/2023, 08/01/2024, 02/02/2024 and 06/05/2024 and 19/06/2024. In this hearing of the appeal on 19<sup>th</sup> day of June, 2024, both the parties found absent without any intimation to the Commission.

The appellant is absent for 3(three) consecutive hearings i.e., 02/02/2024, 06/05/2024 and 19/06/2024 without any information to the Commission inspite of giving information in advance through telephonic call and official correspondence. Last chance and sufficient time was already given to the appellant to appear before the court of Commission, but he failed to comply the direction of the Commission. It seems that the appellant is no more interest in pursuing this appeal case.

In view of the above facts and circumstances, I find this appeal fit to be disposed off in the absence of the appellant. And, accordingly, this appeal stands disposed off and closed once for all.
