Information sought :

The appellant file an RTI Application dated 20/07/2023 seeking Details regarding Fund allocation of Ground Water Scheme under PMKSY-HKCP/CLUSTER SMI Schemes/PMKSY-HKCP and also SIDF/BE/RE/SADA/ ADA/ MLALAD /MPLAD /SPA/SJETA/CCI/CMCSR/BA/SCA-TSS/SWRD of maintenance and supply Work for implement at entire Raga Division from 2012 to till date.

As per the case record, PIO has never conducted the hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 21/08/2023. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Riya Taram & Shri Takam Sakap on **20.07.2023** filed an RTI application under Form-‘A’ before the PIO-Cum-Executive Engineer (WRD), Raga Division, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **21.08.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **29.09.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 944/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 9 (nine) time i.e on **18/12/2023, 19/01/2024, 27/03/2024, 05/06/2024, 29/07/2024, 02/09/2024, 07/10/2024, 02/12/2024 and 13/01/2025**. In this hearing of the appeal on **13th day of January, 2025**, appellant present but PIO found absent. However, the appellant Shri Riya Taram has submitted an application addressed to the SIC to dispose of the appeal case No.944/2023 filed against the PIO-cum-EE (WRD), Raga Division. He has stated that all the information as sought by him has been provided by the PIO and he is satisfied with the information as provided.

Accordingly, the appeal case No. 944/2023 (Appeal) is disposed off and closed once for all.
