1. The Approval of the Chief Secretary for newly created 400 & 500 posts for regularization of service of the eligible Teachers working in various Elementary schools in state of Arunachal Pradesh on contractual basis, separately.

The proposed modalities and the Departmental Regularization Committee which submitted by the Department of Education, GoAP, Itanagar, for the approval to the office of the Chief Secretary, Arunachal Pradesh against the newly created 400 & 500 posts for regularization of service of the eligible Teachers working in various Elementary schools in the State of Arunachal Pradesh on contractual basis, separately, which approved by the Chief Secretary, Arunachal Pradesh.
