**Information sought :**

The appellant file a RTI Application dated 03/06/2023 seeking Details regarding Trading License & proprietor name details.

Being dissatisfied, the appellant filed First Appeal dated 03/08/2023. No any hearing has conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Niper Doni **03.06.2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (RWD), Daporijo Division Upper Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **03.08.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **28.09.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 936/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 29/01/2025 and 17/03/2025. In this hearing of the appeal on 17<sup>th</sup> day of March, 2025, the both the parties found absent without any intimation to the Commission.

On the last hearing dated 29/01/2025, the appellant was directed to be present in person before the commission in the next hearing date and if he is found absent his appeal case will be heard in his absence. Today dated 17/03/2025 on 2<sup>nd</sup> hearing both the parties are absent.

The Commission deems that the appellant has received the information and he is no more interested to pursue the appeal case.

Accordingly, the appeal case No. APIC-936/2023 is disposed off and closed.
