ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Adv. Mamu Sono, Shri Deni Yangfo & Shri Rabo Lochung for non-furnishing of information by the PIO o/o the District Panchayat Development Officer (DPDO) District Tawang (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.11.2023.

The appeal is heard today on 13th of November, 2024 as scheduled wherein the Appellants Shri Mamu Sono, Shri Tania Dongru and Shri Rabo Lochung are absent but the PIO, Shri Tenjin Jambey, the PD-cum-District Panchayat Development officer (DPDO), District Tawang, AP is present.

The PIO informed the Commission that as per records, the o/o the PD-cum-DPDO Tawang had, vide its letter No. TPR/105-2010-11 Dated the 24th Jan, 2024, asked the appellants, to collect the documents pertaining to the information sought by him by depositing an amount of Rs. 6468/- (Rupees Six thousand four hundred sixty eight) only for 3234 pages @ Rs. 2/- per page through Treasury challan being the cost of documents. But, the appellants did not turn up to collect the materials.

The PIO also furnished the copy of the said letter, the copy of hearing notice dated 11-01-2024 served to the appellant by the PIO. o/o the D.C. Tawang, the First Appellate Authority and also the copy of order dtd. 29/01/2024 passed by the F.A.A.

It is seen from the copy of the said order passed by the F.A.A that the appellants did not attend the hearing and as such the F.A.A., after hearing the PIO and upon perusal of the records, disposed of the appeal under section 19 (1) of the RTI Act and directed the appellant to deposit the cost of the documents amounting to Rs. 6,648/- and to collect the information. However, as stated above, the appellants did not collect the documents from the PIO.

The PIO also brought in the documents for handing over to the appellant but since the appellants are absent, the documents could not be hand over to them.

The Commission, thereafter, directs the appellants to collect the documents from the PIO and report their satisfaction or otherwise to this Commission on or before 22nd November, 2024, failing which the appeal shall be disposed of and closed as not being interested for the information any longer.
