ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Lekhi Village, Near Iconic Dealer, PO/PS Nirjuli, Papum Pare District, Arunachal Pradesh for non-furnishing of information by The PIO-cum-Dy State Project Director, Govt. of A.P., SAMAGRA SHIKSHA / ISSE ,RMSA, Itanagar, P/Pare District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 07/03/2022 regarding the details of appointment orders of PTI & PTI Grade-II, PTT, PET, PRT, TGT.

The 11th hearing is held today on 28th May, 2024. Ms. Oyi Borang Tatak, the PIO –cum-DDSE, Govt. of A.P., Boleng, Siang District, Arunachal Pradesh is represented by Shri Tatum Gammi, BEO. the Appellant Shri Nabam Tapak is absent. The representative of the PIO has submitted that the Appellant has not intimated anything about his findings as directed by the Commission in the last hearing.

The Commission observes that the Appellant was furnished with the information and given reasonable time for verification of the information. The Appellant had been given sufficient time to intimate and get complete information. But it is seen that the Appellant has neither intimated the PIO nor informed the Commission of his findings. The Commission on the basis of the cautioned given in the last hearing decides to dispose of this case in view of larger public interest presuming that the Appellant is satisfied with the information furnished by the PIO.

Therefore, the case is hereby disposed of.
