The appellant file an RTI Application dated 06/07/2023 seeking Details regarding Expenditure and Implementation of under SADA/ADA/SIDF/RIDF/RE/CSS of under Kamle District.

Being dissatisfied, the appellant filed First Appeal dated 10/08/2023. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Buli Bhai on **06/07/2023** filed an RTI application under Form-'A' before the PIO-Cum-Executive Engineer (WRD), Raga Division, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **10/08/2023**. Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **19/09/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 925/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two time i.e on 11/11/2024 and 10/02/2025. In this hearing of the appeal on 10<sup>th</sup> day of February, 2025, the PIO-cum-Executive Engineer (WRD) present in person but the appellant Shri Buli Bhai found absent without any intimation to the Commission.

On the last hearing dated 11/11/2024, both the parties were present and the representative of the PIO has stated before the Commission that the information sought by the appellant is kept ready to furnish the information on deposit of Rs. 3,000/- (Rupees three thousand) only for charges of paper. The appellant was directed to collect the information within a month from the date of order. It has been more than 2(two) months but till date the appellant has not collected the information inspite of the order given.

Therefore, the Commission deems that the appellant has no more interest to collect the information and the appellant has been given sufficient time. The Commission deems fit to dispose off the appeal case in his absence. Accordingly, the appeal case No. 920/2023 (Appeal) is disposed off and closed once for all.
