
JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Riya Taram & Shri Takam Sakap on **19.07.2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer(WRD), Yingkiong Division, Upper Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **21/08/2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **19/09/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 953/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 4 (four) times i.e on 18/12/2023, 19/01/2024, 01/04/2024 and 10/06/2024. In this hearing of the appeal on 10th day of June, 2024, both the parties found absent however, PIO detailed his representative namely Er. Kaling Jopir, APIO.

As per order **dated 18/12/2023**, the PIO has already furnished all the information to the appellant as sought by him. As per the record of the case, the appellant is found absent since last three occasion that is on **2nd hearing 19/01/2024, 3rd hearing 01/04/2024 and 4th hearing 10/06/2024** after received of the information from the PIO without any intimation to the Commission. It seems that the appellant is satisfied with the information as provided by the PIO.

In view of the above facts and circumstances, I find this appeal fit to be disposed off. And, accordingly, this appeal stands disposed off and closed once for all.
