The appellant submits that the PIO has not furnished the information documents in reply to his RTI application in spite order from the commission.

On perusal of the records in the case it is seen that showcause was served to the PIO in a hearing order dated 08.12.2023. The PIO did not attend the hearing today and no written representation for his absent and reply to show cause seen. The Chief Engineer (WZ) RWD has written to the PIO cum EE RWD Seppa Division to

comply the order of the commission. The absence of the PIO is observed with displeasure and taken serious note of his negligence to the order of the commission.

One time opportunity is given to Shri Marto Riba PIO cum EE RWD Seppa Division to submit written reply to the show cause order dated 08.12.2023 (copy enclosed) to the commission within 15 days from the date this order. He shall attend next hearing on 10.06.2023 in person. In case of failure to attend the hearing will be conducted ex-parte to take decision for appropriate action.

The hearing is adjourned to 10.06.2024 at 02:00 PM.
