**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Buli Bhai, G-Sector, PO/PS-Naharlagun, District Papum Pare, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-BDO, Govt. of A.P., CD Block Puchi-Geko, Kamle District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 03/02/2022 regarding **Expenditure and implementation under MGNREGA / supply work / pending work / new work/ sanction order / complete work.**

**The 5<sup>th</sup> hearing is held today on 25<sup>th</sup> July' 2024 (Thursday) at 1400 hrs.** Shri Taju Thama, the PIO-Cum-BDO is present. The Appellant Shri Buli Bai is absent. During the last hearing i.e **on 14-05-2024 (Tuesday) at 1030 hrs** the Appellant was advised to verify the information so furnished by the PIO and intimate to the Commission which he did not do. He was also advised to collect information from the PIO. The PIO in his submission said that the Appellant has sought information for 2013-2014 financial year and accordingly he has collected the information and report before the Commission to furnish to the Appellant. Since the Appellant is absent so information could not be furnished. During the last hearing it was clearly intimated, that in case the PIO is absent he will be penalized under Section 20 (1) of the RTI Act, 2005 and if the Appellant found absent the case shall be disposed of without any further notice, presuming that the appellant is satisfied with the information so furnished by the PIO.

Today neither the Appellant has informed about his findings on verification of his information nor present during the hearing.

Therefore, the case is disposed with the direction that the Appellant will collect the information for the year 2013-14 from the office of the PIO.

**The case is disposed of and closed.**
